Recruitment Initiatives

- 1. Continued an intern program created in October of 2012 designed to assist members of the community to acquire skills needed for broadcast employment.
 - a. This is an on-going program with a clear description of work required, time required and room for growth and learning in all areas of station operation including programing, marketing, sales, live broadcasts and more.
 - b. Working with several applicants from surrounding universities under the direction of the station's Program Director and Assistant Program Director, to receive School credit and the necessary skills to work in the broadcast industry.
 - c. The station resumed the internship program post the Covid pandemic.

- 2. The establishment of a mentoring program for our programming staff.
 - a. This is an on-going program with the station's Program Director learning with legendary consulting company RadioAnimal, LLC. They discussed programming philosophies with RadioAnimal's major market stations and listened and participated on music calls and programming discussions with those stations in efforts to offer the Program Director major market radio access for future growth.
 - b. The program also includes close contact with corporate legal council Jason White as well as FCC legal councile on the FCC and business aspects of creating and operating the ownership company. The goal is to teach the station's Program Director operational experience for a future job beyond radio programming with the growing company.
 - c. The station's Program Director and Assistant Program Director were also included in the station rebranding and lead the creative and marketing. Additionally, the Program Director and Assistant Program Director were part of the year's FCC and engineer filings and learned the process from creation to execution.
- 3. Participation in Event/Program sponsored by or on behalf of a community organization related to careers in broadcasting
 - a. Mainestream Media, LLC traditionally opens our studios and offices for those in the public interested in touring the facilities. The focus is to show those interested in a possible career or future in radio the behind the scenes of our product. Those touring have an opportunity to ask questions about the operations of the station, how to find employment opportunities with the station and meet members of our staff.
 - b. The tours are lead by the programming & on-air staff. In 2025, the station hosted the Portland Flames
- 4. Participation in southern Maine Iob Fairs.
 - a. Mainestream Media, LLC traditionally participates in job fairs with local schools and universities.
 - b. In 2025 Mainestream Media, LLC helped amplify several job fairs and recruitment opportunities in southern Maine.
 - c. Mainestream Media was also present at career day at the Biddeford Intermediate School and Deering High School.
